





Delegation of Authority – Cognizant Security Authority

By Statute, the Chief, Defense Nuclear Security is responsible for the development and implementation of physical security programs for the National Nuclear Security Administration (NNSA), including the protection, control, and accounting of materials, and serves as the Cognizant Security Authority for NNSA.

I hereby delegate this authority for implementing physical security programs to you for facilities under your purview. At the Savannah River Site, this delegation will be consistent with the memorandum of agreement, dated July 1, 2009 (or follow-on), between the Savannah River Operations Office and the Savannah



River Site Office. You may re-delegate this authority to the Assistant Manager for Safeguards and Security or equivalent senior security manager at the Site Office or the NNSA Service Center. This authority may not be further re-delegated. All previous delegations of Cognizant Security Authority for implementing security programs are hereby rescinded.
