The requirements outlined in the Clinton Memo are in addition to those specified in the Federal regulations (10 CFR Part 745 and DOE Order 443.1B, <i>Protection of Human Research Subjects</i>). This Notice supplements DOE Order 443.1B and 10 CFR Part 745 by addressing the Department of Energy specific requirements for the protection of human subjects involved in research that is classified, in whole or in part.

In addition, a new physical readiness standard was developed, as well as a reliance upon an occupational medicine physician's determination that our protective force officers can meet required physical readiness standards.</p>
